

# A summary of the adult social care sector and workforce in Gloucestershire 2023/24



Skills for Care is the strategic workforce development and planning body for adult social care in England. We work with employers, Government, and partners to ensure social care has the right people, skills, and support required to deliver the highest quality care and support, now and in the future. Our role is to respond and adapt to the emerging trends and needs within social care, using data and evidence to drive forward widescale change.

The information within this summary has been produced by Skills for Care using the Adult Social Care Workforce Data Set (ASC-WDS). We use the data collected by the ASC-WDS to create workforce models that, in turn, allow for estimates of the whole adult social care workforce and its characteristics to be produced. The \* notation indicates the figure has been suppressed.

## Size and structure of the workforce

In 2023/24 the adult social care sector in England had an estimated 18,500 organisations with 40,000 care-providing locations and a workforce of around 1.84 million posts.



The total number of posts in Gloucestershire was around 22,500 in 2023/24. This was comprised of 21,000 filled posts and 1,300 vacant posts across all sectors.

Since the previous year, the total number of posts were similar, the number of filled posts has increased by 600 (3%) and the number of vacancies has decreased by 500 (27%).

The estimated 21,000 filled posts were split between local authorities (5%), independent sector providers (87%), posts working for direct payment recipients (1%) and other sectors (7%).

In 2023/24, the CQC register showed there were 377 regulated services in Gloucestershire; 203 were residential and 174 were non-residential services.

If the workforce grows proportionally to the projected number of people aged 65 and over then the total number of adult social care posts in the South West region will increase by 35% (from 194,000 to 260,000 posts) between 2023/24 and 2040.

**From here on, the figures in this report refer to the 19,500 filled posts** in the independent sector and local authority only. Filled posts in other sectors are not included.

The independent sector information in this report was collected between April 2023 and March 2024, and local authority information dates from September 2023.

## Recruitment and retention

Skills for Care estimates that the staff turnover rate in Gloucestershire was 26.5%, which was similar to the region average of 26.1% and similar to England at 24.8%. Not all turnover results in workers leaving the sector, around two thirds (66%) of starters were recruited from within the adult social care sector, therefore although employers need to recruit to these posts, the sector retains their skills and experience.



We estimate that the vacancy rate in Gloucestershire was 6.9%, which was similar to the regional average of 7.4% and similar to England at 8.1%.

Across England, the vacancy rate has decreased compared to last year and the number of filled posts has increased. During this period international recruitment increased
